ANSI/TIA-222 is a regulatory standard that establishes requirements for the design, maintenance, and inspection of telecom towers. It is not a standard or regulation, and it neither creates new legal obligations nor alters existing obligations created by OSHA standards or the Occupational Safety and Health Act. Pursuant to the OSH Act, employers must comply with safety and health standards and regulations issued and enforced. Communication Tower Inspection is a critical safety and compliance activity that ensures the structural integrity, operational reliability, and regulatory compliance of telecom towers used for mobile, radio, and data transmission. Adherence to these rules is not optional. It ensures that towers can withstand environmental stressors such as wind, ice, and other activity.
